TELEPHONE, TELEGRAPH, FAX and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry Form are NOT ACCEPTABLE. Entries received without fees will not be accepted. Acknowledgement of entries will be made as soon as practical. Should such acknowledgement not be received by exhibitor within a reasonable time, please notify the Show Secretary.

NO ENTRY shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

ENTRIES CLOSE FOR BOTH SHOWS at 6:00 pm, Wednesday, January 15, 2014, after which time entries cannot be accepted, canceled, or substituted except as provided for in Chapter 14, Section 6 of the Dog Show Rules.

A RECORDING FEE OF 50 cents AND A \$3.00 EVENT SERVICE FEE will be required for each dog entered in any Licensed or Member Club Show, Obedience Trial, Tracking Test, Field Trial or Hunting Test. These Fees are to be collected by the Show-giving Club and paid to the American Kennel Club. (American Kennel Club Rule, Chapter 11, Section 2).

ERROR ON ENTRY BLANKS: Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fees will be refunded in the event of such error or cancellation of entries after the published closing date. There will be no refund for duplicate entries. Returned checks do not constitute a valid entry.

JUDGES ARE NOT REQUIRED TO WAIT FOR DOGS. THEY WILL ADHERE AS CLOSELY AS POSSIBLE TO THE JUDGING SCHEDULE. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is being judged. The Show-giving Club and the Show Secretary have no obligation or responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

INSTRUCTIONS

1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard)
2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship
3. (Event Class) Consult the classification in this premium list if the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3)
